

# **Crossroads Bank eStatement Promotion Official Contest Rules**

### **Contest Period**

The contest begins at 12:00 am (eastern time) March 1, 2025 and ends at 11:59 pm (eastern time) on December 31, 2025. Entries must be received by 11:59 pm on December 31, 2025 to be eligible for a prize drawing.

## Eligibility

- 1. No purchase necessary to enter or win. You do not need to have an account at Crossroads Bank. Utilizing any other bank services will not improve your chances of winning.
- 2. The contest is open to individuals 18 years of age or older who are legal residents of the United States at the time of entry.
- 3. Employees, directors (and household family members of such employees and directors) of Crossroads Bank and its advertising, promotion, and fulfillment agencies, and their affiliates, are NOT eligible.

#### **Automatic Entry**

- 2. Enrollment is complete upon the acceptance of the electronic statement terms & conditions disclosure, entering a valid email address and clicking "Submit." This allows you to receive your statements electronically in lieu of paper statements via US Postal Service.
- 3. New eStatement enrollments must take place between March 1, 2025 and December 31, 2025 to be entered in the contest.

#### **Alternate Method of Entry**
